Admissions

We offer enrolments subject to availability, throughout the year. Our aim is to make the admissions process a seamless, straightforward experience. Application Process

Step 1:

Please speak to your Admissions Manager to find out how to apply or submit an application online at www.ais.com.sg. Applications are considered in chronological order of receipt. Each applicant is reviewed individually and independently.

Step 2:

Prospective students need to submit all required forms and documents online and pay a non-refundable Application Fee in order to be considered for admission.

Step 3:

Once the required forms and documents have been submitted and the Application Fee has been received, the application will be reviewed.

Step 4:

Once a place is offered, you will be asked to confirm your acceptance of the place by submitting the online student contract. You will then receive an invoice for the payment of Enrolment fees.

Prior to your child starting they may be invited to attend an Orientation Day, if they are due to start at the beginning of a term, or an enrolment meeting, should they start school mid-term.

Wait List

If a place is not available at the time you wish to join, your child's name will be added to the waitlist and

you will be notified as soon as a place is anticipated. Please notify the Admissions Department of any changes of address or other contact details or if your circumstances change.

Sibling Priority

AIS aims to welcome all family members into our community. As such, our first admissions priority is given to families with children currently attending AIS. Acceptance into year levels with very limited places will be reserved for children with a sibling or multiple siblings already enrolled at AIS or with applications submitted. Siblings will also be given first priority should there be a wait list in their year level.

Singapore Citizens/Singapore Passport Holders

Approval is required from the Ministry of Education (MOE) before a Singaporean applicant (6 years old and above) is allowed to attend classes at AIS. The application for approval from the MOE will be sent once a place has been offered. Please note that

Singaporean applicants to AIS who are 6 years old and above will be offered a place subject to MOE approval and no place will be reserved for the student until the approval has been granted by the MOE.

Student Pass

The following students will require a Student Pass:

- Students whose parents are Permanent Residents of Singapore, but the student is not
- Students who are not eligible for a Dependant's Pass (for example step children)
- Where neither parent has an Employment Pass

AIS will register a child requiring a Student Pass with the Immigration and Checkpoints Authority (ICA) when a place is offered and parents will process the application from there. Please note that applicants to AIS requiring a Student Pass will be offered a place subject to Student Pass approval and no place will be reserved for the student until the pass has been issued by the ICA.



Student Pass holders can commence classes after the student ID has been issued. Student Pass holders must meet the minimum 90% monthly attendance requirements stipulated by the ICA.

Learning Enrichment Program

AIS offers a Learning Enrichment Program for students who require support. The needs of eligible students will be assessed on an individual basis and parents should inform the Admissions Department of any learning needs prior to making an application from enrolment.

English as an Additional Language / Intensive Language Course

The school offers additional educational support in English for eligible students for whom English is not their primary language. The school will determine on a case- by-case basis if English as an Additional Language (EAL) support is required as a condition of continued enrolment. Students remain enrolled in EAL support until they are proficient and no longer needing support.

International Students

International Students are important members of the school community.

International Secondary School students (Year 6 - Year 12) are eligible for enrolment as Homestay

students. Homestay students are required to reside at the School's appointed boarding house, 21 Linden Drive or with an appointed adult guardian who is responsible for their supervision and care at all times.

International Elementary School students (Prep - Year 5) are not eligible for enrolment as Homestay students and may only be enrolled if they are residing in Singapore with their parents or with an appointed member of their direct family.



Application Check List

The following items are required at the time of application and are all needed before an application can be reviewed:

- Completed and signed online Application Form
- Application Fee per child
- Health Promotion Board Immunisation Registration (all applicants 12 years and under)
- Soft copy of applicant's passport
- Soft copy of applicant's birth certificate
- Official transcripts or report cards for the current year and two years prior to current year level (if needed translated into English and certified), including any NAPLAN or standardized test results (if applicable)
- Reference form to be completed for Elementary students and older

The following items are mandatory once a place has been offered and before your child starts school:

- Copy (front and back) of Singapore pass/visa
- Copy of immunisation record
- AIS Health Declaration Form, submitted online
- Contact details in Singapore
- Student Contract, submitted online
- Tuition fee payment



2023 School Fees Schedule Pre-Nursery to Year 12

All charges are expressed in Singapore Dollars (SGD) and are inclusive of GST. These fees are payable per student and are adjusted annually. School fees include all textbooks, workbooks and yearbook. The proration of fees is applicable if the student commences during a semester. For new families only, course fees are charged on a per month pro-rata basis (irrespective of start date within the month) if the student begins their course after the academic semester has commenced.

Fees are non-transferable. Tuition refunds are available in accordance with the withdrawal notification dates contained in the student contract and terms and conditions.

Discounts

- Enrolment Fee: 50% discount on the Enrolment Fee for the application of a third child and a full waiver of the Enrolment Fee for a fourth child and beyond.
- Facility Fee: 50% discount for enrolment of a third child at AIS and a full waiver of the Facility Fee for a fourth child and beyond.
- Tuition Fee: 5% discount for the third child in a family and 10% for the fourth child and beyond. (Discounts are applied from the oldest to the youngest. For example, if there are three children in the family, the youngest child will receive the discount.)
- Returning Families/Alumni Fee Discount: 100% discount of both the Enrolment and the Facilities Fees apply to all returning AIS families.

This discount also applies to the children of former AIS students.

School tuition fees are payable direct to the School either annually or in two equal instalments.

Payment by Instalments

We also offer the credit card instalment plans offered by DBS/POSB credit cards. At the time of processing, the full amount charged(1-Semester's school fees per child) is blocked against the cardholder's credit limit but is not actually charged to the card. The block against the credit limit decreases over the payment period as the monthly instalments are charged to the card by the Bank and paid by the card holder. You will need to visit our Finance Office in person to process the credit card instalment payment plan (IPP).

Non-Refundable Enrolment and Facility Fees

The Enrolment Fee are payable in full at the time of acceptance in order to secure a place. If payment is not received within 7 calendar days of receipt of the school's invoice, priority will be given to other applicants. Both the Enrolment and Facility Fees are one-time administrative fees that may only be

refunded in certain circumstances, prior to commencement of enrolment.

Returning Students

A top up of the Application Fee would be required if there is a change in fees.

Tuition Fee

The Tuition Fee includes all textbooks and workbooks. For students commencing after the start of the academic year, the Tuition Fee is payable immediately. Students will not be able to attend classes unless all fees have been paid.

Technology Fee

The Technology Fee provides access to all of AIS's technology resources and includes service provision for maintenance of required hardware, software, security systems and infrastructure. AIS's education technology reflects the school's commitment to providing the best resources for our students and includes iPads in Preschool and Elementary, MacBooks for Secondary, promethean boards, video-conferencing facilities and more. The Technology Fee is not included in the tuition

instalments and must be paid annually prior to the student's start date.

English as an Additional Language (EAL) Program Fees

The EAL Program Fee is payable by term in addition to the Tuition Fee. Specialist teachers are arranged to provide this service and as such, the EAL Program Fee is non-refundable should the student subsequently withdraw from the program.



Infant Care

Infant Care is a stand-alone program that is housed at the Early Learning Village. Fees and terms will differ from that of the main school.

Infant Care Fees

Fees are payable from the 1st of the calendar month and are not prorated should an infant join the program on any other day throughout the month.

Fees are revised in October of every year.

Payment Terms

Monthly Infant Care Fees are payable before enrolment to the program and are payable 2 months in advance.

Infant Care fees are non-refundable. Monthly Infant Care Fees are payable before enrolment to the program and are payable 2 months in advance. Infant Care fees are non-refundable.

The initial invoice will be for the first 3 months of fees. At the end of the first month, AIS will invoice again but for 1 more month in future. This means that at any time, at least 2 months of fees will be paid for in advance.

Withdrawal Terms

A formal notification of withdrawal from the AIS Infant Care Program is required at least two (2) calendar months in advance of the intended withdrawal date. Withdrawal dates are only permitted to be on the last day of a month, and full payment for the month will be payable irrespective of the student’s actual last day.

Application and Enrolment Fee waiver to AIS Pre-Nursery program

The Application Fee and Enrolment Fee for the Pre-Nursery program at AIS will be waived for any child who has been enrolled at Infant Care program for at least 6 continuous months prior to graduating.

Other Terms

Other terms and conditions pertaining to Infant Care can be found in the Infant Care Contract. Please speak to your Admissions Manager for additional support.

Infant Care School Hours

The Infant Care Program runs 5 days per week.
The Centre is open from 8.00am – 6.00pm. If care is needed after 6.00pm (due to parent / guardian running late for evening collection) a charge of \$10 per 10 minutes will be applied.

Elementary School Extended Care and Holiday Care

Extended Care and Holiday Care are stand alone programs in the Elementary Year 1 Pod offered to families with children in Prep, Year 1, and Year 2 only.

Extended Care

Extended Care runs during the school term from 3.00pm – 6.00pm daily. Families who wish to make use of the Extended Care program can sign up at the beginning of each term for whichever days they choose, in line with their child's school schedule. Fees will be pro-rated if starting midway through a term:

Holiday Care

Payment by Employers or Third Parties

If school fees are to be paid by a company/employer please complete the Letter of Guarantee and submit it to the Admissions Manager. An authorised representative from the company/employer will need to sign and stamp this form. Parents are responsible for keeping their employer/company informed of all information regarding Tuition Fee, payment terms and all other fees. Financial responsibility for all school fees remains with the parents irrespective of payments made by third parties.

Goods and Services Tax (GST)

GST at the prevailing rate will be applied to all school fees and will be reflected on your invoice where it applies. Australian International School Pte. Ltd. is registered with the Comptroller of Goods and Services Tax. Our Company Reg. No. is 199204405H and GST Reg. No. M2-0108834-8. The GST rate established as of 1 January 2023 is 8%

Non-Refundable Application Fee

Additional Information

Agreement

Parents are advised to read the School's Terms and Conditions thoroughly before submitting a formal application for enrolment. Your signature on the application form implies an acceptance of the Terms and Conditions. Detailed Terms and Conditions are available on the school website.

Cancellation of Acceptance

If, for any reason, parents cancel their acceptance of a place before the student starts at the school, the Application, Enrolment and Facilities Fees will not be refunded. Tuition Fees paid in advance will be refunded provided sufficient notice has been given. For cancellation after the student's commencement, please refer to "Withdrawals".

Canteen

The AIS canteen offers hot meals, snacks and drinks for students before, during and after school. Main meals and snack items can be pre-purchased via our parent portal, Connect AIS and collected by students. Alternatively, students from Year 3 - Year 12 can purchase items themselves using cash or

using the student smart-card, which can be topped up online or at top-up stations on campus.

Compulsory Trips and Activities

The Tuition Fee does not include compulsory school activities and field trips within and outside of Singapore that form part of the AIS Outdoor Education Program. Extra curricular school trips and sports trips are also not included in the Tuition Fee. All students in Prep - Year 10 take part in the AIS Outdoor Education Program. Costs associated with these excursions and trips vary.

The Admissions Department can provide you with further details of recent camps and activities and their associated costs.

Deferment of Acceptance

Once a student is accepted and the Enrolment Fees have been paid, a place is secured. Should it be necessary, a student may defer their school start date for up to one year from the initial start date indicated in the acceptance letter. After a one year

deferment, the acceptance will no longer be valid and the student will need to re-apply.

If for any reason, acceptance is cancelled by the family before starting school, the Application, Enrolment and Facility Fees will not be refunded. For additional information see “Cancellation of Acceptance.”

School Changes

This school, like any other, is likely to undergo a number of changes during the time your child is enrolled. For example, there may be changes in the staff, in the premises, facilities and their use, in the curriculum, the size and composition of classes, the Handbook, the Terms and Conditions, the disciplinary framework and the length of the school year. Tuition fees will be regularly reviewed and adjusted annually.

Student Contract

The Student Contract is an important legal document between the school and each student that details the Course Information and Fees, Refund Policies, Fee Protection Scheme (FPS) by LONPAC Insurance Pte Ltd and Medical Insurance Scheme by Medical Insurance Scheme by AEGIS Insurance Agencies Pte Ltd. Execution of this contract before a student

starts school is a legislative requirement of the Committee for Private Education and provides extra protection for AIS students.

Transportation

AIS offers a point to point bus service for the regular school hours, subject to demand. A third-party transport partner, Johnson Transport, provides this service. The Transportation Fee is invoiced separately and is in addition to Tuition fees. Uniform

All students are required to purchase the official AIS formal and sports uniform, as applicable. The AIS uniform should be purchased from our official provider, Lim Meng Keng, #02-18 Holland Road Shopping Centre, 211 Holland Avenue, Singapore 278967 +65 6468 3655. Sample sizes can be viewed and fitted, and orders collected from the AIS Uniform Shop.

Withdrawals

Tuition Fees are non-refundable in whole or in part if withdrawal is after the commencement of a

semester. Parents must submit the withdrawal form online via our online parent portal, Connect AIS. Deadline for submitted withdrawal notice, Semester

1, by 19 October, Semester 2 , by 13 April. Please note email notification is not accepted as written notice.

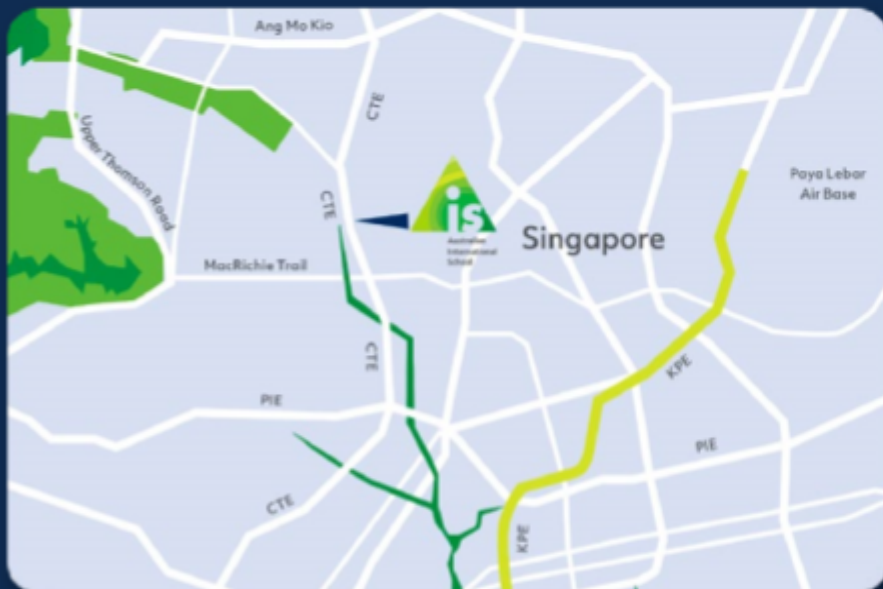
